Important facts

*Please be informed that the invitation letter that will be issued by this order is **not a visa** and is **not sufficient to enter Russia**. To obtain your Russian business visa you will need to apply to your local/nearest Russian consulate using this invitation. When you receive your invitation by email or as an original, we advise that you contact your travel agent or local/nearest Russian consulate for details. The amount of EUR 100/ EUR 120 will cover your invitation letter only. A separate payment for your Russian visa has to be made to the consulate or your travel agent.

***Please be aware that the invitation letter is issued within 30 days.** Please also be informed that Western Gate will try to obtain your invitation letter as soon as possible, but in some cases the Foreign Ministry can detain the issue of invitations. In such situations Western Gate will take advantage of every option to accelerate this procedure, but cannot guarantee a positive outcome and neither Western Gate nor ICEF are responsible for any consequences of such delays.

***Please be aware that proof of medical insurance is required to enter Russia.**

*Every person who is not a citizen of Russia must be in possession of a **migration card** that is provided at the airports in Russia. Please complete the migration card before passing through customs and immigration at the airport. When completing the migration card, make sure to indicate in the section 'Purpose of visit' the reason of your visit corresponding to your visa type. Please note that, as a foreign visitor, you must also have a hotel registration and confirmation secured for the entire period of your visit. This information will be added to your migration card at the reception desk of your hotel when checking in.
